## VETERAN BEWARE!!

**Veteran Email Scam:** An old e-mail scam has reappeared and is targeting veterans. Recently forwarded throughout the Army community and titled "Warning To Veterans," the current version of the e-mail advises against using the services of an organization called Veterans Affairs Services. An earlier version of this e-mail, purportedly from Michael G. Daugherty, staff attorney with the Department of Veterans Affairs, Office of General Counsel, contains a Facebook link that may be an attempt to upload a virus according to Better Business Bureau (BBB) Military Line officials. The BBB advises anyone receiving this e-mail not click on the link. Also, the VA advises veterans seeking assistance to use a VA-recognized service organization in order to submit a claim for benefits. [Source: Military.com Veterans Report article 17 Jan 2011 ++]

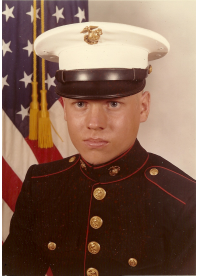


## Veterans Corner

**BOB LLOYD**

**MARINES  
1983-1985**

Robert Lloyd was born in Stoughton Wisconsin on May 11, 1964. Bob attended Stoughton High School, but left early to join the United States Marine Corps. Bob enlisted in 1981 and went to Boot Camp in San Diego, California on May 13, 1981, two days after his 17<sup>th</sup> birthday.

After Boot Camp, Bob was sent to the deserts of Barstow California for 4 months for an on-the-job-training course in supply and warehousing, which he successfully completed.

In January 1982, Bob was sent to Okinawa Japan for his one year of overseas duty. In Okinawa, Bob worked as a security guard for the base armory the entire year; recounting many harrowing experiences. During that time, war in the Middle East was gearing up and terrorism was just getting started. Even in Okinawa. It was here Bob earned his high school diploma from the State of Wisconsin.

Upon leaving Okinawa, Bob was sent to Camp Legume, North Carolina to finish out his last 2 ½ years of service. Bob was assigned to HQSVCO, HQSVBN to work as a warehouseman in the largest Battalion supply warehouse in the Marine Corps. The wars in Beirut and Grenada as well as the many deployments and training kept them extremely busy.

Bob eventually worked his way up to the position of Warehouse Chief, as a corporal, a position customarily held by a Staff or Gunnery sergeant. Bob was in charge of every aspect and function of the warehouse. It was at Camp Legume that Bob met his wife Mary, who was also a marine stationed at Camp Legume.

One exciting duty that Bob was responsible for was to set up the warehouses first computerized inventory system. One day a computer arrived at the warehouse and the Lieutenant instructed Bob to get it up and working. Bob, with the help of Mary, both of which had any computer

experience, set up the computer, installed the software and data entered the entire warehouse inventory. This was no small feat and was done outside the normal work hours. Bob and Mary worked almost every night and weekend for over a month until it was up and running.

While stationed at Camp Legume, Bob recalls being invited to join Force Recon, a Special Forces battalion and offered a position in sniper school. Bob declined the offer and impending 6-year re-enlistment and deployment and was discharged in May 1985 after 4 years of honorable service.

While in service, Bob was awarded the Sea Service Deployment Ribbon, Good Conduct Medal, the Navy unit Commendation along with three consecutive Rifle Expert Badges. Not an easy task on a Marine Corps Rifle Range. This is what prompted the invitation to join the Force Recon Battalion.

Bob came back to Stoughton and joined the Madison-based Marine Corps Reserve Unit, 2<sup>nd</sup> BN, 24<sup>th</sup> Marines while working at Universal Silencer, a division of Nelson Industries.

Bob attended some college and took many technical courses and eventually got a job with the State of Wisconsin as an income tax auditor.

Bob has recently enjoyed his 25<sup>th</sup> wedding anniversary with Mary, his two grown daughters, Traci and Christi, and granddaughter Rayana.

Bob has been a member of the Stoughton American Legion Post 59 for 18 years, qualifying for membership because of the wars in Beirut and Grenada.

Bob has held many officer and committee positions serving 2 years as the Post Finance Officer and has been the current Post Service Officer for 4 years. Bob also served Post 59 as the Secretary of the 2006 American Legion State Convention Corporation, helping plan and coordinate the entire state convention.

Bob was instrumental at organizing a chapter of the American Legion Riders in the Stoughton and District 3 area serving two years as the District Vice President and two years as the District President earning many state and national awards. Bob currently serves as the State President of the American Legion Riders Association of Wisconsin.

Bob also serves as the Sr. Vice Commandant of the Marine Corps League 4 Lakes Detachment of Madison Wisconsin, a position he has held for 4-5 years.

Bob has served the community, state and nation for many years and looks forward to continuing to do so.
